The Future of Cooperation between the EU and Ukraine

Kiel (Germany) on Friday, 4 July 2014

On 27 June 2014 the EU and Ukraine have signed the new Association Agreement (AA), which provides for intensive political and economic cooperation. Ukraine has expressed its hope to become a member of the EU in a foreseeable future. Russia has declared its concern about the Association Agreement, which it sees as seriously affecting Russia's relations with Ukraine. The announced Conference will give information and the possibility to discuss in depth the perspectives of cooperation between the EU and Ukraine once the present exacerbated crisis has been resolved. The Conference brings together diplomats, scientists (law and economics) and representatives of business. Relations with Russia will be taken into account, but the focus will be on the relationship EU-Ukraine.

The Conference is organized by the Institute of East European Law of Kiel University in cooperation with other institutions.
